YOU WILL NEED TO HAVE YOUR APPLICATION INTO OUR OFFICE AT LEAST 14 DAYS PRIOR TO THE EXAM DATE REQUESTED. YOU WILL RECEIVE A CONFIRMATION LETTER WITH THE DATE YOU ARE SCHEDULED TO TAKE THE EXAM ALONG WITH A MAP TO THE FACILITY.

IF YOU ARE A NON-RESIDENT OF OHIO YOU MUST COMPLETE THE IRREVOCABLE CONSENT TO LEGAL SERVICE FORM.

AT TIME OF APPLICATION YOU MUST SUBMIT 2 PASSPORT PHOTOS.

YOU MUST SUPPLY YOUR OWN REFERENCE MATERIAL. THIS WILL BE A TWO PART EXAM AND YOU WILL BE GIVEN THREE HOURS TOTAL TIME TO COMPLETE BOTH SECTIONS. THE EXAM WILL BEGIN PROMPTLY AT 1:00 P.M. YOU MUST PRESENT A PHOTO ID TO BE SEATED FOR THIS EXAM.
