Filing Instructions

- A. Application must be typewritten or neatly printed.
- B. Submit a check or money order in the amount of \$75.00 Payable to: **Treasurer, State of Ohio.**
- C. This permit is for explosive manufacturing/processing and directions for the inspector.
- D. Submit a copy of the required corporate surety bond in the principal sum of \$1,000,000 or a public liability insurance policy for the same amount, for the purpose of the payment of all damages to persons or property which arise from, or caused by, the conduct of any act authorized by the permit upon which any judicial judgment results.
- E. Submit an electronic background check indicating that the applicant has not been convicted of a felony under the laws of this state, another state or the United States as provided in the Ohio administrative code (OAC) 1301:7-7-33(A)(2)(f).
- F. Incomplete applications will be returned, all fees are non-refundable.

SUPPLEMENTAL PERMIT FILING INSTRUCTIONS FOR EXPLOSIVE MANUFACTURING/PROCESSING

Effective November 1, 2012, the Ohio Administrative Code (OAC) 1301:7-7-33(A)(2)(f) requires our office to verify that applicants for a permit to manufacture, process, or store explosives and/or explosive material, have not been convicted of a felony prior to the issuance of an initial or renewed permit. To better serve our customers, our Bureau is now using the Webcheck Electronic Criminal Background Check system. This system uses fingerprints as well as an individual's social security number and date of birth. This service is provided in our office. However, if you have been fingerprinted within thirty-six months of your renewal date for any approved reason (i.e. school employee, conceal & carry permit, fireworks exhibitor, ATF or TSA licensure) and the results are based on a national search, those results may be submitted as part of your application.

The following information should be provided when applying for an explosives manufacturing/processing permit:

1. A map indicating the location of the explosives manufactured/processed. Indicate the distance of each explosive manufacturing site from the nearest building(s), highways, and railway(s). (A county highway map is acceptable)
2. A complete address (Please do not use P.O. Boxes)
3. Indicate the distance of each explosives manufacturing/processing site from the nearest building(s), highways, railway(s), and from each magazine.
4. A copy of the corporate surety bond in the principal sum of \$1,000,000 or a public liability insurance policy for the same amount, for the purpose of the payment of all damages to persons or property which arise from, or caused by, the conduct of any act authorized by the permit upon which any judicial judgment results.
5. Provide phone number(s) of the responsible person(s) who will accompany our inspector to the site or location for the purpose of inspection.
6. Provide a description of your method of manufacturing/processing of explosives.

The regulations governing permits for explosives storage and explosive material storage are in Rule 1 and 33 of the Ohio Fire Code. NFPA 495, 2006 edition is the standard for explosive manufacturing, processing, storage, and use, incorporated into the Ohio Fire Code by reference.

When the above information and completed application is received by our office, a fire safety inspector will visit the site to conduct an inspection. Upon receipt of the inspection report, your permit will be issued if no code violations are found.

Please check with other appropriate agencies (i.e. the local fire code official, ATF) to ensure that you are in compliance with all other requirements for permitting/licensing at the local and federal levels.

NOTE: When a permit is not required by the local fire code official to engage in any hazardous activity set forth in the appendix to rule 1301:7-7-01 of the Administrative Code (Ohio Fire Code), the person intending to engage in the hazardous activity shall first notify the local code official of that person's intent to engage in that hazardous activity.
