Annual Appraiser Renewal Applications

The Division will continue to mail renewal applications to credential holders. If you need to renew or take any action to maintain your license, certificate, or registration between March 9, 2020, through the end of the emergency period declared by Governor DeWine, <u>H.B. 197</u> gives you a 90-day window after the emergency period has ended or until December 1, 2020, whichever is earlier, to submit your renewal application or take other actions necessary to maintain your license.

Education Providers

Appraiser continuing education offerings originally designed to be presented in a traditional classroom setting may be offered remotely in a distance education setting without delivery mechanism approval if the provider satisfies all the following:

- 1. The educational offering under consideration is currently approved <u>by the Ohio Division of Real Estate</u> for traditional classroom presentation;
- 2. The platform utilized for distance education is live and interactive students must see the instructor and the instructor must see the students:
- 3. The instructor verifies photo identification of the students; and
- 4. The instructor maintains an attendance roster, which includes verifying 100% classroom attendance by, for example, taking attendance at various established times during the course.

As of April 3, 2020, this will affect only appraiser continuing education offerings and does not apply to appraiser qualifying education offerings. Education providers seeking an offering subject to these requirements must submit, prior to the course offering, a completed modification form to the Division for review and approval. This regulatory accommodation is only valid during the National Emergency.
