



# Manufactured Home Salesperson’s License Application

- New Application** (fingerprinting required – see below) – **Fee \$153.50\***
- Transfer and/or Reinstatement** – **Fee \$28.50\***
- Duplicate License** – **Fee \$25.00**

\*Full-time or part-time salespersons **must** apply for a salesperson's license immediately upon being hired by the manufactured home dealer, and shall be prohibited from offering for sale, displaying for sale or selling manufactured homes until licensed. All Ohio residents applying for a new salesperson's license must be electronically fingerprinted (BCI&I Only). The fingerprint results have to be received directly from the BCI to the Division of Real Estate & Professional Licensing (Division). Fingerprint cards are only used for out-of-state applicants. \***Out-of-state applicants** may submit a fingerprint card and exemption form in lieu of having their prints electronically scanned. Please contact the Division at 614-466-4100 to obtain a fingerprint card and an exemption form.

**NOTE: Reason Code is “Other”. Limited background checks run by the Division are solely for licensing purposes specifically addressed in Ohio Administrative Code 4781-11.**
