Talooyinka Maccaamiisha Marka ay Iibsanayaan ama ay Iibinayaan Hantida Maguurta.

Ganacsiyada Hantida maguurtada ah waxay noqon kartaa dhib iyo jahowareer. Hoos waxa kuyaal tallooyin laga yaabo inay caawiyaan guri ibsadaysha ama iibiyasha si looga dheeraado dhibatooyinka caadiga ah marka la iibsanayo ama la iibinaayo hantida ma guuraanka ah.

1. Baro Wakiilkaaga Hantida Maguuraanka: La tasho Qeybta Hantida Maguurta ah & Laysiinka Xirfadda nidmaakooda onlaynka ee Laga-eego Macluumaadka Laysinka si aad u barato wax badan oo ku saabsan hantida maguurta ah ama dalaalka, sida haddii ay tahay ama aan laga rajo qabin waakiilka inay u haysto laysin laga iibiyo hantida maguurta ah gudaha Ohio haddii ay sidaas tahay, haddii ama isaga ama iyada laysiinka uu aysan ku wanaagsanayn. Waxaa sidoo kale laga yaaba inaad si toos ah ula xirirto Qaybta si aad u aragto haddii la buuxiyay cabasho iyo/ama laga qaaday taalabo wakiilka ama dalaalka aad rabto. Waa inaad ka jawaabtaa su'aalahaan kahor inta aadan aaminin qofka wakiilka kaa ah si u wakiilk kaga noqdo adiga mida ugu muhiimsan iyo ganacsiga ugu qaalisan ee noloshada.

2. Doorshada Aamhiyaha iyo Fahamka Sharuudaha: Maalgelinta waa qaybta ugu weyne ee nidmaaka gadashada guriga haddii ay tahay markii ugu horeysay ee aad gadanayso guri ama iska gadayso gurigaa si aad u gadato guriga cusub. Marka aad isbarbar-dhigto kharashyada qaadashada lacaga daynta ah iyo doorshada aamhiyaha, waa inaad sidoo kale hubsata inaad fahamto waxa uu ka rabo aamiyahaaga inaad samayso. Aamhiyayasha waa inay, tusaale, ku siiyaan ogeysiin qoraal ah haddii aysan isticmaalaynin leysinka Ohio ama qiimeeyee la aqoonsanyahay si uu qabto qiimayntaada. Laysiinka ama qiimeeyaha shahaada haysto waa inuu raaca heerarka iyo gobolka ee qiimaynta marka uu qabanayo qiimaynta halka qiimeeyaha aan haysanin laysinka ama shahaadama qaban karaan qiimaynta. Waxaa laga yaaba inay tahay fikrad wanaagsan inaad ku amarto qiimeeyntaada qof shahaado haysto ama qiimeeye laysin leh haddii uusan isticmaalaynin amaahiyahaagu mid.

3. Fahamka Lagaca Carbuunta iyo Xisaabaadka Keydsan: Aqbalidda heshiiska, iibsadayasha waxay degayan debaajiga iimaanka wanaagsan, ee loo yaqo "lacagta carbuunta," si ay muujiyaan in ay dhab ka tahay iibsiga guriga. Wakiilka Hantida Maguurtada ah, haddii mid ka mid ah u ku lug leeyahay ganacsiga, kadib waa in lacagta dhiga dalaalkiisa akoonti aamin ah isaga ama iyada., Haddii xisbigu ay ku heshiisho qiimaha ama aqbalo, xisbiga dhawacan waxaa laga yaaba inuu helo carbuunta lacagta, waxay ku xiran tahay heshiiska iibsiga. Si kastaba ahaate, sharciga Ohio waxaa uu u baahanyahay ibsadyaasha iyo ibiyaasha inay saxiixan sii daynta waddgista ka hor labada dhinac inta aysan gaarin lacagta dalaalka.
